The Shivalaya Rural Municipality, Jajarkot invites sealed quotations from registered Suppliers for the Supply and delivery of Fabricated Steel Parts for **Baluwa Suspended Bridge** at Shivalaya Rural Municipality. Fabricators with experience of successfully completing supply of fabrication and steel parts for minimum five trail bridges within last five years are eligible for the bidding.
